**GENERAL EXPLANATIONS**

In Article 11 of the Law on the Protection of Personal Data ("PDP Law"), certain rights have been granted to the personal data owners (hereinafter referred to as "data subject") regarding the processing of personal data defined in Law No. 6698 in PDP Law.

In accordance with the first paragraph of Article 13 of the Law on PDP, the applications to our Institution as the data controller shall be communicated in writing or by other means determined by the Personal Data Protection Council ("the Council").

In this framework, the print out of the "written" applications to our Institution have to be taken,

- With identity verification in hand,
- By means of notary,
- Signed with the "secure electronic signature" defined in the Electronic Signature Law No. 5070

and sent to us.

The above-mentioned channels are "written" application channels in accordance with the first paragraph of the Article 13 of PDP Law. Once the other methods determined by the Council are announced, our Institution will also announce how these applications will be received by way of these methods.

According to the second paragraph of the Article 13 of PDP Law, the applications you send to our Institution, depending on their nature, will be responded by our Institution in max thirty days as of the day we receive them. As per the provision of the Article 13 of PDP Law, our response will be sent to you in writing or by means of electronic media.
